Personal Information may include: Application Information: Information you provide on applications and other forms, such as your name, address, birth date, government-issued identification, occupation, assets, income, etc. Verification Information: Information necessary to verify your identity, such as a passport or driving license, and background information from public records or other entities not affiliated with Veyron Markets. Sensitive Personal Information may include: Information about your transactions with us, account balances, and bank account/credit card information.

Once your account is opened via the website, you automatically become a Client and are provided with a unique account number, which becomes your User ID, along with a password for managing your account. The information you provide upon registration is passwordprotected, ensuring that only you have access. Veyron Markets will never ask for your password through unsolicited phone calls or emails. By completing an account application and submitting the required documentation, you are disclosing personal information to Veyron Markets, which will not be used without your consent.
